## **WHITMER SIGNS \$4.4 BILLION K-12 SUPPLEMENTAL**

Governor Gretchen Whitmer signed a supplemental spending bill for Michigan's K-12 schools into law on Wednesday, significantly increasing funding and per-pupil equity for the state's K-12 schools and laying the foundation for the completion of the rest of the state budget.

The funding approved by the Legislature last week includes a 10 percent increase in the per-pupil funding for students from \$8,100 to \$8,700. The per-pupil funding brings all districts to the same basic per-pupil foundation grant, which has been a goal for lawmakers and education groups for decades.

House Bill 4421, signed by Whitmer on Wednesday, releases \$4.4 billion in federal coronavirus relief aid. As Public Act 47 taking effect Wednesday, the bill holds \$3.35 billion from the American Rescue Plan Act, and \$840.1 million from the CARES Act II.

“We have a once-in-a-lifetime opportunity to make the type of investment in our schools that will put Michigan students and educators first as they head into the next school year. Our actions today prove that Republicans and Democrats in Lansing can work together to enact budgets that are laser-focused on helping Michigan take full advantage of the unprecedented opportunity we have right now to make transformative investments in our schools that will have positive impacts for generations,” Whitmer said.

## **LEGISLATURE SENDS SCHOOL BUDGET TO WHITMER**

The Legislature approved a \$17.1 billion K-12 funding plan last week, right before their self-imposed July 1 deadline, with bipartisan support.

Lawmakers called the bill the “largest investment in education” in Michigan’s history.

The proposal garnered support in both houses with the Senate approving funding 33-1 before adjourning until July 15, and the house approving the funding 106-3. The plan included bill 4421 which Gov. Whitmer signed earlier this week, boosting the base per-pupil foundation allowance to \$8,700.

The final Senate-passed plan is close to a proposal backed last week by the House and Gov. Whitmer. With the Senate version including \$240 million for school psychologists, counselors, social workers, and nurses, \$155 million in reading scholarships, and \$168 million for Michigan’s Great Start Readiness Program.

As the July 1 deadline passed without a full budget, Whitmer said she was encouraged by the progress but disappointed the legislature adjourned without a full budget.

The House and Senate have until Oct. 1, when the state fiscal year begins, which means the House and Senate will continue working on the budget after the Senate returns from its summer break, with decisions needing to be made on how to distribute billions of dollars in federal stimulus money.

## **NESSEL ACCEPTS REPUBLICAN REQUEST TO INVESTIGATE PEOPLE PROFITING FROM ELECTION CONSPIRACIES**

Michigan Attorney General Dana Nessel's office confirmed Thursday that the department will investigate individuals who gain publicity or profit by spreading misleading and false information about the 2020 election results.

The investigations come after the release of a Republican-led Senate Oversight Committee report that concluded that there was no evidence of fraud in the 2020 presidential election. The report also recommended that the attorney general consider investigating individuals who have used the misinformation "to raise money or publicity for their own ends."

"After reviewing the report in full, the department has accepted Sen. McBroom and the committee's request to investigate. (The Department of State Police) is also assisting in the matter," said Attorney General spokesperson Lynsey Mukomel.

Although the report did not specify individuals to be investigated, it did cite former state Sen. Patrick Colbeck and Portage attorney Matthew DePerno, who was retained by an Antrim County resident for a lawsuit against the county. Colbeck had made claims in testimony about the integrity of election equipment. The report found both individual's claims to be "demonstrably false" and "based on misleading information and illogical conclusions."

In addition, several online fundraisers have collected money by pushing the idea that the presidential election was wrongfully stolen from Donald Trump.

Senate Oversight Committee Chair, Sen. Ed McBroom (R-Vulcan) said the investigation recommendation was made to the Department of Attorney General because the committee had taken the matter as far as it could.

## **SUPREME COURT DENIES REDISTRICTING DEADLINE EXTENSION**

The Michigan Supreme Court today denied a request from the Independent Citizens Redistricting Commission for a deadline extension to propose and adopt new political maps for congressional and legislative districts.

The commission had proactively petitioned the court for new deadlines because of a six-month delay in the Census data, which is used to draw the new districts.

The court said it would not grant the request for a deadline extension.

In a concurring statement attached to the court's order, Justice Elizabeth Welch wrote that "through no fault of its own, the commission is in the unenviable position of undertaking its inaugural redistricting cycle without the full benefit of tabulated decennial census data."

Welch also wrote that granting the request would be premature before the redistricting commission actually misses the deadline and before there are any legal challenges brought against the commission. Writing that the court declines the "invitation to clothe the commission or the secretary of state with any lawsuit-proof vest."

The state Constitution requires the 13-member commission to propose new maps by Sept. 17 and requires at least 45 days for public comment on the proposed maps before adopting the maps by Nov. 1.
